Globally, 2023 was a turbulent and eventful year. This situation caused considerable fluctuations in the medical, social and economic spheres. Our foundation has therefore mainly used this year (2024) as a phase of planning and institutional strengthening.

Within the foundation, the **IDEIS Education and Research Institute** has been further expanded and organisationally strengthened.

The number of volunteers actively contributing to the foundation's work has grown to nine. With this strong team, various innovative activities have been launched, including the **ZELVI** pedagogical certification programme, in which approximately 150 participants took part.
